STUDENTS RIGHT TO CANCEL: The student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session (first day of classes (//), or the seventh day after enrollment (seven days from date when enrollment agreement was signed(/), whichever is later.
